2. Summary of complaint

The Complainant has set out that in her view, in the period leading up to and during a Full Council meeting of Okehampton Town Council on 30 September 2019 Cllr Vachon:

- Failed to treat her with courtesy and respect,
- Failed to have regard to professional advice,
- Bullied or intimidated her and
- Brought the office of Councillor or the Council in disrepute.


3. Outcomes:

4. <u>Decision and reasons:</u>
Decision: to take no further action
<p>Reasons for decision:</p> <p>Following the Formal Assessment of the Complaint and the Decision Notice issued on 13 December 2019, the matter was referred for Investigation. The Investigating Officer found the following breaches of the Code of Conduct:</p> <p>4(a) you must treat others with courtesy and respect, 5(c) you must not bully any person and 5(h) you must not conduct yourself in a manner or behave in such a way so as to give a reasonable person the impression that you have brought your office or the Council into disrepute.</p> <p>On 10 March 2020 and before a resolution or sanction could be agreed, Cllr Vachon resigned as a Councillor of Okehampton Town Council.</p> <p>In accordance with section 11.5 of West Devon Borough Council's procedure for 'Dealing with Complaints' the complaint will not be considered any further and this Complaint is closed.</p> <p>There is no right of appeal or review of this decision by the Complainant or Cllr Vachon.</p>
